







Total Bankruptcy Cases 1980 - 2023




All Cases Monthly vs Unemployment Rate




Monthly Average Filings All Cases 2022 – 2024 Q2




All Cases 2023 vs. 2024 YTD - State Volume

Trends by Quarter, % Change, Same QTR One Year Prior























Chapter 11 Related Cases 2018 - 2024 (Percent of Total Chapter 11 Filings)




Large Cases Filed By Quarter 2020 - 2023




Very Large or Notable Chapter 11 Cases Filed March 2020 – June 2024









All Individual Cases 2023 vs. 2024 YTD






Chapter 7 Filing Trends By Quarter (Percent Change From Same Quarter One Year Prior)






% Homeowner Filings by Chapter, FY 2008 - 2023




(Households Up to 60th Percentile Income)




